Upon enrolment of my child/ren at The River School, I agree and understand the following:

### **SCHOOL PHILOSOPHY**

1. I support the aims and ideals of The River School within school grounds, school events and on the school bus.
2. I agree to adhere, to The River School's sentient vegetarian food policy (no meat or meat products, eggs, onion, garlic or mushrooms).
3. I agree to supply healthy food choices with minimal packaging for my child's lunches and snacks. 'Junk food' is not permitted at school.
4. I understand that inappropriately branded clothes and paraphernalia/toys/gadgets are not to be brought to school.
5. I will encourage my child/ren to participate to take full advantage of the curricular and co-curricular activities at school such as meditation, yoga, morning circle, music and sport.
6. I will uphold the values of Neohumanism such as love, compassion, connection, respect and honesty, in all dealings with the school and school community.
7. I agree to engage with our school community in a supportive and loving manner that honours all families, staff and children.
8. I agree to attend school events where possible and embrace opportunities to broaden my knowledge and understanding of Neohumanist Education through attendance at workshops and seminars.

## **SCHOOL POLICY**

9. I understand that all enrolments are subject to a one month trial before my child's enrolment can be formally finalised. A student's enrolment can be cancelled by the school or parents at any time during this one month trial period.
10. I am aware that the school's policies are available for viewing at any time in the school foyer and will familiarise myself with these.
11. I agree to adhere to The River School's Staff Code of Conduct Policy when assisting in school related activities at The River School.
12. I agree to support the school in matters of policy relating to grievance procedures. I have read and understood The River School's Grievance and Complaints Policy.
13. I agree to present any concerns or grievances directly to the school in a respectful manner conducive to problem solving and working towards an appropriate resolution.
14. I understand that The River School is a peanut free school and that no products containing peanuts are to be brought onto school grounds or to school events.
15. I agree to adhere to the school's Student Behaviour Management Policy that incorporates the School's philosophy on student behaviour including our Bully Prevention Policy, Restorative Practice principles, and our School wide Behaviour Support Framework.

## **SCHOOL FEES**

18. I understand that **written** notification of my child's termination of enrolment at the River School must be given one term in advance. One term's school fees will be charged in lieu of notice given.
